

SPRING AHEAD LOAN SPECIALS

ADDENDUM AND INFORMATION

EFFECTIVE MARCH 1ST THROUGH MAY 31ST 2017

#1 SPRING AHEAD LOAN : \$800

Loan terms:

- To qualify for the **SPRING AHEAD CASH LOAN #1**, your monthly income must average at least \$1200. Repayment term up to 12 months/52 weeks. Member may choose weekly or bi-weekly payments.
- Interest rate is 18.00% APR.

#2 SPRING AHEAD LOAN : \$1000

Loan terms:

- To qualify for the **SPRING AHEAD CASH LOAN #2**, your monthly income must average at least \$1800. Repayment term up to 12 months/52 weeks. Member may choose weekly or bi-weekly payments.
- Interest rate is 18.00% APR.

#3 SPRING AHEAD LOAN : \$1200

Loan Terms:

- To qualify for **SPRING AHEAD CASH LOAN #3**, your monthly income must average at least \$2400. Repayment term up to 12 months/52 weeks. Member may choose weekly or bi-weekly payments.
- Interest rate is 18.00% APR.

REQUIREMENTS:

- **APPLICATION FEE: NON-REFUNDABLE, \$50, for each non-credit qualifying loan request.**
- Funds must be available in your share account or accompany loan request.
- LOANLINER ® APPLICATION required.
- You must be a member of Bashas' Associates Federal Credit Union for a minimum of six months and at least 18 years of age.
- You must have been employed for a minimum of 6 months with your current employer.
- All BAFUCU accounts must be in good standing and must be current (no negative balances or late payments) 6 (six) months prior to receiving a new non-credit qualifying loan special (does not include eligible Overdraft Advantage). Income verification required for each loan. (Copies of two (2) most current paycheck stubs.) You may not have more than one non-credit qualifying loan at a time.
- Any balance on a non-credit qualifying loan may be refinanced by another non-credit qualifying loan.
- If you have had a bankruptcy in the past 12 months, currently have a garnishment, or any type of judgment, you may not qualify. Be sure to discuss these credit issues with your loan officer at time of application. You may be asked to provide details in writing prior to loan approval and funding.
- BAFUCU loan officer may determine a need to obtain a credit report to verify bankruptcy, garnishment or civil judgment information.
- Additional conditions may exist.
